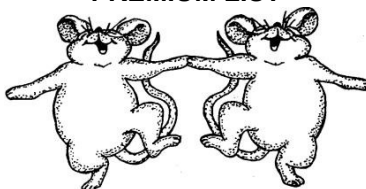

ELIGIBILITY

Dogs must be at least 6 months old. Only complete entry forms including Registration/ILP/PAL numbers will be accepted.

Introduction to Quarry: 10 feet, one 90 degree turns.

*** REGULAR CLASSES:**

Junior Earthdog: 30 feet, three 90 degree turns. Open to all dogs that have not earned a Senior Qualifying leg.

Senior Earthdog: 30 feet, three 90 degree turns, with false den and exit, recall. Open to all dogs that have completed a JE, SE or ME title.

Master Earthdog: 30 feet, three 90 degree turns, with false entrance, den and exit, indication of entrance, honor another working dog. Open to all dogs that have completed a SE or ME title.

Special COVID-19 Event Rules

Earthdog Practice & Tests July 16, 17 & 18, 2021

1. All attendees who are vaccinated may self-attest to their vaccination status and avoid the requirement to wear a face mask and social distance.
 - You will receive a colored wrist band when you check-in which you must wear during the event.
2. All attendees who are not vaccinated for Covid-19 are required to wear face masks that cover the nose and mouth at all times during these tests and maintain 6 feet social distance with people outside your household. This includes when waiting to enter den areas, handling their dog, or whenever standing or walking where other may come near them.
 - You will receive a colored wrist band when you check-in which you must wear during the event.
3. There will be no food (hospitality or lunch) provided at this event. Bring your own lunch and snacks and consume them in your vehicle.
4. If you feel sick, have any COVID-19 symptoms, or have been in contact with any known carrier of COVID-19, do not come to the tests.
 - Email the secretary for a full refund. Refunds will be issued by mail after the tests.
 - If you have an IQ dog and may want to enter him in Junior, pre-entry is required. If, after running Intro, you want to withdraw, see the Test Secretary at least 30 minutes prior to the start of the Junior Earthdog class.
5. We will announce each class orientation.
6. Ribbons will be available self-serve. There will be no award ceremonies.
7. To retrieve your dog from the den in IQ, Junior & Master, the judge will unlock the opening over the working area, step 6 feet away, and only then should you approach to remove your dog.
8. All requirements of the Washington State Agricultural Event Guidelines, the AKC Earthdog Guidance for COVID-19, and Center for Disease Control recommendations will be adhered to.

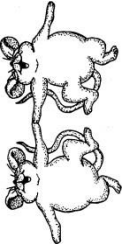
